**Student Expulsions**

A recommendation for expulsion has been made regarding Anchor Bay High School students #1498071694 and #1507406899 who are charged for the theft of a high school teacher's automobile (Michigan State Police report #24-2096-05). At the conclusion of their 10 day suspensions, the students will be expelled for 30 school days beginning May 25, 2005 and ending September 26, 2005. The students will return to school on September 27, 2005.
